This list does not include prices for certain items that you may ask us to purchase for you, such as, cemetery services, flowers, and newspaper notices. The price for those items will be shown on your statement describing the funeral goods and services you selected.

## SERVICES, FACILITIES, AND EQUIPMENT

### 1. SERVICES

#### Basic Professional Services of Funeral Director and Staff..... \*\$ 1145.

This is the charge to each family that we serve for our professional expertise in assisting them. It includes, but is not limited to, a proportionate share of the taxes, licenses, utilities and business expenses necessary to serve the public in a professional manner. Also included in this charge is the consultation with the family, clerical and administrative services, preparation and filing the necessary permits, consultation with clergy, cemetery, crematory or common carrier, planning the funeral, and placement of obituary notices. There will be an additional charge for the direction and supervision of each service requested or required. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

#### 2. EMBALMING ..... \*\$ 495.

Embalming is a chemical process that provides temporary preservation, disinfection, and restoration of the body. A person licensed by this state must complete this procedure. Except in certain special cases, embalming is not required by law. However, embalming may be necessary if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

### 3. OTHER CARE OF THE DECEASED

- a) Dressing, cosmetology and casketing..... \*\$ 240.
- b) Washing, disinfection of unembalmed remains for viewing..... \$ 100.
- c) Dressing of unembalmed remains when requested ..... \$ 100.
- d) I.D. viewing - 30 minutes..... \$ 125.
- e) Post autopsy care..... \$ 200.
- f) Organ and tissue retrieval restoration..... \$ 250.
- g) Refrigeration charge of unembalmed remains, per day - after first 24 hours..... \$ 55.  
State law requires either refrigeration or embalming within 24 hours of removal.
- h) Sheltering of embalmed remains beyond 7 days (per day) ..... \$ 55.

### 4. USE OF FACILITIES, STAFF AND EQUIPMENT

- a) Funeral/Memorial service conducted at funeral home ..... \*\$ 495.
- b) Viewing conducted at funeral home - 2 hours..... \*\$ 250.
- c) Overtime charge for staff for evening services ..... \$ 150.
- d) Overtime charge for staff on Saturday ..... \$ 250.
- e) Overtime charge for staff on Sunday and Holidays..... \$ 350.

### 5. USE OF STAFF AND EQUIPMENT

- a) Funeral/Memorial/Graveside service conducted at another location ..... \$ 345.
- b) Viewing conducted at another location – 2 hours ..... \$ 345.
- c) Overtime charge for staff for evening services ..... \$ 150.
- d) Overtime charge for staff on Saturday ..... \$ 250.
- e) Overtime charge for staff on Sunday and Holidays ..... \$ 350.

### 6. AUTOMOTIVE EQUIPMENT

- a) Local removal and transfer of remains to funeral home (25-mile radius)..... \*\$ 360.
- b) Second attendant required for transfer ..... \$ 100.
- c) Transportation per loaded mile..... \$ 2.80
- d) Use of funeral coach and driver for local transportation (each use)..... \*\$ 260.
- e) Use of limousine and driver for local transportation (ask for quote) ..... \$ \_\_\_\_.
- f) Utility/flower vehicle and driver (each use)..... \*\$ 150.

### 7. CREMATION

- a) Crematory facility & staff ..... \$ 330.
- b) Crematory facility & staff (over 300 lbs)..... \$ 525.
- c) Witness Cremation ..... \$ 125.
- d) Scattering of cremains ..... \$ 295.
- e) Mailing of cremains..... \$ 150.
- f) Mailing of cremains in a custom urn..... \$ 200.

\*Included in complete traditional funeral service.

**8. COMPLETE TRADITIONAL FUNERAL SERVICE ..... \$ 3,395.**  
Includes basic professional services of funeral director and staff, local transportation from place of death to our facility, embalming and other preparatory care, use of our facilities and staff for visitation, facilities, equipment and staff services for mortuary funeral ceremony, funeral coach to local cemetery, and utility/flower vehicle.

### ALTERNATIVE SELECTIONS

**1. FORWARDING REMAINS TO ANOTHER FUNERAL HOME ..... \$ 2,280.**  
Includes local removal & transfer of remains, embalming, basic professional services of funeral director and staff, and transportation to airport. This charge does not include merchandise, viewing of remains or funeral ceremony.

**2. RECEIVING REMAINS FROM ANOTHER FUNERAL HOME..... \$ 1,685.**  
Includes removal of remains from airport, basic professional services of funeral director and staff and coach to local cemetery. This does not include viewing of remains, funeral ceremony, or merchandise.

**3. DIRECT CREMATION – Range in price from: ..... \$ 1,405. - \$ 7,560.**  
Includes local removal & transfer of remains, basic professional services of funeral director and staff, and crematory facility & staff. This charge does not include viewing of remains, funeral ceremony or embalming/refrigeration.  
If you want to arrange a direct cremation, you can use an unfinished wooden box or alternative container. Alternative containers encase the body and can be made of materials like fiberboard, or composition materials (with or without an outside covering.) The containers we provide are constructed out of cardboard and particleboard. We also provide veneer, hardboard, pine, oak and cherry cremation caskets.

- a) Direct cremation with container provided by purchaser ..... \$ 1,405.
- b) Direct cremation with alternative container, heavy cardboard box..... \$ 1,455.

**4. IMMEDIATE BURIAL – Range in price from: ..... \$ 1,765. - \$ 7,760.**  
Includes local transfer of remains, services of our staff and coach to local cemetery. This charge does not include merchandise, viewing of remains, funeral ceremony or embalming/refrigeration.

- a) Immediate burial with container provided by purchaser ..... \$ 1,765.
- b) Immediate burial with a fiberboard laminate casket container..... \$ 2,210.

**5. BODY DONATION ..... \$ 1,505.**  
Includes the services of funeral director and staff and local removal charge. Additionally, body donation forms are available from us and we will assist you in making arrangements for body donation. This fee does not include transportation to medical facility, or refrigeration after 24 hours.
